Dear President Biden:

As leaders of several faith traditions, we write to urge you to offer strong leadership in the upcoming seventh replenishment of Global Fund to Fight AIDS, Tuberculosis and Malaria (Global Fund). Thank you for the Secretary of State announcing the United States will host it. It is vital and urgent that the U.S. do more to help spare the most vulnerable and marginalized from infectious disease—whether AIDS, tuberculosis or malaria as longstanding killers, COVID-19, or inevitable pandemics yet to come.

Thank you for offering moral and practical leadership at home and globally on the challenges brought to light by the current pandemic. Given the Global Fund's strengths, one of the best ways to offer and show the world leadership is by championing the seventh replenishment. The United States leading by example with an early and bold pledge of one third of the Global Fund's replenishment goal (as past Administrations have pledged), along with hosting replenishment, is the most effective way to leverage contributions from other donors.

The Global Fund partnership is estimated to have saved over 44 million lives since its inception in 2002. In that time, the number of precious lives extinguished by AIDS, TB and malaria annually has been cut by nearly half in countries where the Global Fund works. Yet COVID-19 has devastated the AIDS, TB and malaria responses to which you and the United States have been committed so humanely for two decades. For the first time in the Global Fund's history, progress against the three diseases has gone backwards because of COVID-19's impact on access to care. Comparing 2020 to 2019: HIV prevention services reached 11% fewer people and HIV tests declined by 22%. About one million fewer people with TB got treated. Inroads against malaria – which killed over 400,000 people in 2019—stalled due to COVID-19.

The Global Fund has taken on the disruption of AIDS, TB and malaria programs, and COVID-19's direct harm, through its COVID-19 Response Mechanism. U.S. emergency funding to that mechanism has allowed the Global Fund to rapidly respond to local governments' and communities' requests. The Global Fund is the largest provider of the non-vaccine components of the COVID-19 response, including oxygen, PPE, tests and therapeutics.

Since you championed major financing of pandemic preparedness and response recently at the UN General Assembly, we appeal to you to use the Global Fund to the fullest. The partnership has enormous capacity for

serving the needs and dignity of communities—bolstering health systems and frontline health workers, engaging affected populations and delivering to remote places with its supply chain acumen.

The Global Fund has a record of inspiring other donors to step up alongside the United States (not least because U.S. law requires their generosity amount to at least twice as much our own). Please pledge one-third of the Global Fund's Replenishment target. We urge you to use the replenishment to encourage other world leaders to invest in re-accelerating progress on AIDS, TB and malaria; in saving lives now from COVID-19; and in nurturing health systems and pandemic preparedness.

Humankind's victims of poverty, stigma, discrimination and neglect have a right to prevention and treatment resources so that they can withstand life-threatening pandemics and epidemics. By championing the Global Fund as a proven, adaptable lifesaver, you will lift up millions of lives, restore U.S. leadership and, yes, inspire others to follow suit.
